# Grounds for the International Complaint

The grounds for this international complaint include but are not limited to acts of international terrorism perpetrated by ANTIFA organizations and members, known and unknown, as well as violations of numerous Articles within the Universal Declaration of Human Rights (UDHR), to wit;

#### Incidents with known ANTIFA involvement:

On March 28, 2016, a fight occurred between ANTIFA members and supporters of the US President during a rally in Seaside Heights (Ocean County).

On August 12, 2017 a rally in Charlottesville, Virginia turned deadly as a result of a carramming incident (one death and 19 injuries) as well as an additional fifteen (15) injuries related to other violence during the rally.

On August 27, 2017, peaceful demonstration in Berkeley, CA turned violent when ANTIFA members, some with mace and clubs, clashed with protesters and US President supporters.

### Definition and Identification of ANTIFA

For purposes of this Warrant for Arrest, ANTIFA is hereby defined as a conglomeration of autonomous groups and individuals that promote, as a means to effectuate political change, the violation of Human Rights as well as endorse physical violence and civilian property damage. The "decentralized" character of ANTIFA demands that the definition of ANTIFA also include unaffiliated individuals subscribing to a similar doctrine of political opposition. ANTIFA groups and members are known to use social networking platforms to create presence and distribute communications. ANTIFA groups and individuals are known to coordinate regionally and champion causes such as racism, sexism anti-Semitism, fascism and other perceive injustices. ANTIFA groups and members often attend public events wearing face-masks and may be armed with mace, clubs, stabbing instruments and guns.





### ORDER FOR ARREST

By the authority granted this office by the National assembly, it is hereby ordered that any and all are hereby authorized to detain, incarcerate, and in the case of violent resistance, use deadly force against ANTIFA and ANTIFA members, to maintain the peace within the established metes and bounds and seaward boundaries of The United States of America.
