HARRY MITCHELL (AZ-05)

Mitchell Opposed Measure to Ban Use of Matricular Consular

In 2006, Mitchell voted against a proposed ballot measure to ban the use of Matricular Consular cards.

Subject to voter approval, the proposal would prohibit law enforcement or other government agencies, commissions, boards or districts from accepting identification documents unless they are issued by a political subdivision, Indian tribe, a state or federal authority.

The Matricular Consular is an identification card issued by the Mexican Government through its Consular Offices. Every Mexican national, independent of his or her migratory status, has the right to be registered by the Mexican Consulate within the jurisdiction where he resides. Some Mexican nationals who are present in the U.S. utilize the Matricular Consular as a form of identification.

The measure passed 18-11. [SCR 1030, Third Reading, 3/6/06]

Mitchell: Opposition to Matricular Consular "Crazy"

In 2003, Mitchell voiced his opposition to legislation that would bar cities from recognizing the Matricular Consular.

"I think it's crazy," Mitchell said.

Mitchell also pointed out that he's pleased that the Tempe City Council has chosen to accept the IDs for city services.

"People have said over and over that it does not have anything to do with a person's immigration status," he said. "I think this is an anti-immigration thing." [*Arizona Republic*, 3/10/03]

GABRIELLE GIFFORDS (AZ-08)

CHRIS MURPHY (CT-05)

Murphy Voted Against Restricting Validity of Drivers Licenses to Certain Aliens

In 2003, Murphy voted against an amendment that allowed the Commissioner of Motor Vehicles to restrict validity of a driver's license or ID card to coincide with the period of a person's lawful presence in the United States, unless the person proved they had applied for a change or extension of their authorized presence.

The amendment passed 20-16. [SB 930, RC #391, Amendment B, 5/29/03]

Opposed Requiring the DMV to Verify Social Security Numbers Before Issuing a Driver's License

In 2004, Murphy voted against an amendment that required the Department of Motor Vehicles to check the social security number with the Social Security Administration for applicants' who use a social security card for identification prior to issuing a driver's license.

The amendment failed 15-21. [SB 124, RC #114, Amendment B, 4/14/04]
