On 08/27/12 at approx. 1044hrs, members of the Baltimore County Police Department responded to Perry Hall HS; 4601 Ebenezer Rd 21236 for a gunshot wound. It was determined that Robert Wayne Gladden Jr. w/m 08/05/97 entered the school cafeteria armed with a shotgun and began shooting. Suspect Gladden fired the first shot at one of the first lunch tables in the cafeteria and struck Victim Daniel Borowy in the back. School staff immediately confronted the suspect in an attempt to disarm him only to have the suspect fire a second shot that went into the ceiling. The suspect was disarmed and placed under arrest by the School Resource Officer G. Gephardt #3093. Victim Borowy was flown to Shock Trauma and admitted for treatment.

All events did occur in Baltimore County MD.
