

PROBABLE CAUSE STATEMENT

Crime: 7 X 187 (a) PC, 3 X 664/197 PC

Suspect 1: Goh, One L

Date & Time: 02 Apr 12, 1033 hours,

Location: 7850 Edgewater Dr.

On April 2nd 2012 at about 1121hrs, Safeway security officer called Alameda PD and reported that a man admitted to shooting several people in Oakland. Suspect was detained by Alameda PD and transported to Oakland PD. Suspect was positively identified by at least three witnesses and surviving victims as the person who entered the school located at 7850 Edgewater Rd. Oakland and started shooting on April 2nd 2012 at about 1030hrs. Seven people were killed and three additional people were wounded by gunshot wounds. During the interview, the suspect admitted to going to 7850 Edgewater Rd. in Oakland with a .45 caliber handgun and four fully loaded magazines of ammunition. He admitted to kidnapping a woman and forcing her from her office into a classroom at gunpoint. He admitted to shooting and killing several people inside the classroom, before taking one of the victim's car keys and fleeing the scene in the victim's car.
