On 9/13/97, at 1702 hours Deputy Hunziker arrived on scene at 13791 Mayfield Rd. in regard to a Domestic in progress. Upon arrival Deputy Randolph and Sgt. Philbrick were already in the residence speaking with the suspect, Thomas Lane. The complainant Sarah Nolan was outside the residence. At this time, Deputy Hunziker started to obtain information on the events of the afternoon, when Deputy Hunziker heard someone yelling in the rear of the house, Deputy Hunziker then ran to the rear of the house where Sgt. Philbrick and Deputy Randolph were wrestling with a very combative suspect, Thomas Lane. After many verbal commands to Thomas to stop resisting arrest, to no avail. Deputies Randolph and Hunziker progressed in the escalation of force by spraying Thomas with pepper spray. Thomas then broke free and started running north bound towards Mayfield Road. Deputies repeated the command to cease in his attempt to flee from the deputies, Thomas continued to run northbound and did in fact run across Mayfield Road into a grassy field where the subject was apprehended, but continued to fight. Deputy Randolph made a strike with his baton and struck Thomas in the leg. Sgt. Philbrick also used his baton on Thomas to keep the subject on the ground while Deputy Hunziker placed the handcuffs on him. He was taken into custody at 1705 hours. Deputy Vetter transported Thomas back to the Safety Center where the corrections officers decontaminated the suspect. At this time Deputy Hunziker noticed that his flashlight and flashlight holster were missing and were unable to be located after the foot pursuit. (Above items are valued at \$56.00, Scorpion Stream light \$38.00, leather holster \$18.00) Deputy Hunziker then obtained the information from the complainant, Sarah Nolan, who stated Thomas was upset over dinner, threw it at the wall, proceeded to take and throw everything out of the cupboards, push Sarah in the back, pull her hair and threatened to kill her. Deputy Hunziker did view the damage in the house. Sarah signed the complaint form for Domestic Violence and Temporary Protection Order was signed, and Victim Witness numbers were given to Sarah. Sarah was also advised that she needed to be in court on 9/15/97, at 8:00 AM for the hearing. Thomas was charged with Domestic Violence ORC 2919.25 M-1 as well as ORC 2921.33 Resisting Arrest M-2 and Assault on a Peace Officer ORC 2903.13 (A-3) F-4.

Thomas was asked while incarcerated if he wanted to give a statement, Thomas stated he would talk to the Judge at court. Deputy Randolph and Sgt. Philbrick will submit supplement reports as to what happened prior to Deputy Hunziker's arrival. Deputy Hunziker was asked by Thomas to take pictures of his body which Deputy Hunziker did.

On 13 September 1997 at 1700 hours the sheriff's office was dispatched to 13791 Mayfield Rd in Claridon Township, the home of Thomas Lane and Sarah Nolan for a reported domestic violence complaint. Initially Nolan was disconnected by Lane grabbing the phone away from her. Dispatch called back but Lane grabbed the phone again and ripped it out of the wall. Upon arrival Sgt. Philbrick met with the complainant Nolan who was crying. Deputy Randolph arrived too and went inside with Lane who could be heard yelling from outside. Nolan stated that Lane had gone out of control and threw a TV dinner at her and had been pushing her all around the house violently. Nolan also stated that Lane told her once he knew GCSO was enroute that he would kill her if he was arrested. Nolan having stated this, Sgt. Philbrick went inside to affect the arrest of Lane. Lane was in the kitchen and speaking in an agitated tone with Deputy Randolph. Sgt. Philbrick advised Lane he was under arrest for domestic violence and was going to jail. At this point Lane stated "oh no I am not", and ran out the back door of the residence. Both Deputy Randolph and Sgt. Philbrick gave verbal commands to Lane to stop running, but he continued running towards the woods in full running stride. Deputy Randolph body tackled Lane and took him to the ground. At this point Lane became extremely combative and assaultive toward arresting officers. Lane was kicking, punching and continually attempting to get up and flee. Deputy Randolph and Sgt. Philbrick constantly gave Lane strong verbal commands to cease his resisting. As Lane's resistance increased so did the force necessary to affect his arrest. Sgt. Philbrick applied a stun gun to Lane's chest and gave him verbal commands to roll over and put his hands behind his back. Lane continued to resist and continued to try to get back on his feet. At this point Lane kicked Sergeant Philbrick in the groin and got on his feet and punched Sgt. Philbrick in the neck area. At this point Sgt. Philbrick advised deputies to use pepper spray on Lane. The pepper spray was not immediately effective and Lane continued to fight and ran into the front yard into a group of pine trees. Deputy Hunziker applied more pepper spray to Lane and advised him to lay down on the ground. Lane then ran across the street into the neighbor's yard. Deputy Randolph chased close behind as did Sgt. Philbrick. Lane stopped running at one point once across the street but would not lay down and was struck by Deputy Randolph with baton in the large leg muscle in an attempt to make him fall to the ground. Lane continued to not follow strong verbal commands to lay down. Sgt. Philbrick came up behind Lane and used the baton to push on Lane's back to get him on the ground. Lane fought all the way to the ground and once down would not put his hands behind his back as instructed. Sgt. Philbrick gave repeated blows with a closed fist to Lanes biceps and shoulders to gain compliance for hand cuffing. Deputy Hunziker had to struggle all the way until the last handcuff was closed. Lane was transported to the jail and his face was hosed off with cool water for relief from the effects of pepper spray. The jail staff then allowed Lane to take a long shower.

At 1656 hours on 9/13/97, Deputy Randolph responded to 13791 Mayfield Road in Claridon Twp. in reference to a Domestic Violence incident.

While on scene, Deputy Randolph witnessed Sgt. Philbrick inform the suspect, that he was under arrest. The suspect stated he was not going to jail and fled on foot out the back door of the residence at that location.

Deputy Randolph and Sgt. Philbrick pursued the suspect and through out this incident. Both Deputies continuously gave strong verbal commands for the suspect to lie down on the ground. As the suspect continued to flee, Deputy Randolph used strong arm tactics to place the suspect onto the ground attempting to complete a lawful arrest.

Once on the ground, the suspect became extremely combative with the Deputies. Sgt. Philbrick used an electronic restraint device in an attempt to subdue the suspect, but it was ineffective. The subject repeatedly kicked Sgt. Philbrick and attempted to punch the Deputies. Deputy Hunziker, having just arrived on scene, administered a dose of aerosol pepper spray. The suspect remained extremely combative in spite of the pepper spray, and again fled on foot.

Sgt. Philbrick advised the Deputies to use a tactical baton to subdue the suspect, The suspect fled through the front yard of the residence, across Mayfield Road and into a field. The suspect then stopped, facing away from Deputy Randolph with his hands up. Deputy Randolph gave two separate orders for the suspect to lie on the ground. The suspect ignored Deputy Randolph's orders, and Deputy Randolph struck the suspect with an Asp baton on the side of the suspect's right thigh. Deputy Randolph again instructed the suspect to lie on the ground. The suspect ignored Deputy Randolph and Deputy Randolph again struck the suspect's right thigh with his Asp baton, the suspect then complied with Deputy Randolph's orders and was placed into custody.

On the above date and time, Deputy Sulak arrived at Geauga/University Hospital Emergency Room, in response to a domestic violence report. The emergency room staff reported the incident. A woman arrived at the hospital, was reported to have been beaten by her ex-husband, and was badly bruised. Deputy Sulak was directed to examination room #10 and met with victim, Julie Grey, and her mother, Linda Grey.

Upon initial contact with Julie Grey, Deputy Sulak observed that Julie had numerous bruises about her face, neck, and arms.

NOTE: The following events occurred as reported by the victim, Julie Grey. However, due to the length of time the incident occurred and the victim's levels of disorientation and consciousness, the order in which the events took place may not be in sequential order as written in this report.

Julie first stated that she has been divorced from her husband, Thomas M. Lane, since March 6, 2002, ending a five-year relationship (three years dating and two years married). Julie and Tom continued to live together at 13791 Mayfield Road, Claridon Township.

Julie stated that, on April 5, 2002, at approximately 8 p.m., she had been speaking with her parents on the telephone about the possibility of her moving back home with her three children (Tyler, age 6 from a previous relationship; Anna & Alyssa, age 3). Julie told her parents that her present living arrangement with Tom was worsening day-by-day.

At approximately 10 p.m., after speaking with her parents, Julie called a man (Joe-last name unknown) she met at Geauga County Job & Family Services earlier in the day to ask about job opportunities and other questions about J&F Services. Tom had been listening in on Julie's conversation and said that he had tapped the telephone line. Tom then accused Julie of having an affair with Joe.

Julie stated that Tom became extremely upset and demanded Joe's telephone number. Julie said that she had been in several rooms in the house by this time and could not remember where she had placed the card with Joe's telephone number written on it. Tom then threw Julie down on the kitchen floor and began kicking her in the head several times. Julie told Tom that she would find the number and prove to him that she was not seeing Joe. Julie began searching from room to room looking for the telephone number with Tom following her. Tom would grab Julie by her hair and push and slam her around. At one point, Tom threatened to kill Julie and then himself.

Julie further stated that, at some point, Tom grabbed her by her throat and began to strangle her to the point that she could not breathe and she began to lose consciousness for several seconds at a time. Deputy Sulak did observe redness and bruising around Julie's throat.

Julie continued to search for the telephone number while Tom continued to yell and scream at Julie, "Find it, bitch. You're a slut and a whore!" When Julie searched the laundry room, Tom pushed Julie's face down into the washing machine and held her there while he turned on the cold water and reached for a utility hose in the sink next to the washing machine. Tom placed the end of the hose over Julie's face and allowed the water to run over her nose and mouth making it difficult for Julie to breathe. Julie yelled at Tom begging him to stop.

Julie said that she made several attempts to get to the telephone to call 911, but Tom kept her away from the telephone and then unplugged it. Julie then attempted to reach the door to get outside, but Tom grabbed her and pushed her onto the couch.

Julie said that while in the kitchen, Tom placed his hand over her mouth and nose and told her, "You're screwed, bitch! It's all over for you!" Julie believed that she was going to die. Sometime later while in the kitchen again, Tom had Julie by the hair and pushed her head into the wall, breaking the drywall and leaving a large hole.

Julie also stated that she went into her daughter's bedroom in the hope that Tom would stop beating her and calm down if she held her daughter in her arms. Julie held Anna who was crying loudly. Tom did begin to calm down and lead Julie to the couch while she held Anna. Tom then began to say how sorry he was and what a jerk he had been. Tom went to the kitchen and returned with a bag of frozen vegetables to place on Julie's head. Tom said that he wanted Julie to stay with him. Julie said that she wanted to leave with the kids.

At approximately 1 a.m., it appeared to Julie that Tom was going to allow her to leave the house with the kids. Julie went to Anna and Alyssa's bedroom and began dressing them to leave. Tom followed and became angry again when he realized that Julie was indeed leaving. Tom grabbed Julie by her hair and twisted it up over her head. Julie was holding her daughter in her arms.

At approximately 5:30 a.m., Tom allowed Julie to leave the house because the children were crying and screaming and would not stop. Julie left the house with her children and drove her car to Marathon at Mayfield and Aquilla Road to buy gasoline. The clerk at Marathon took notice of Julie's condition and asked if Julie was okay. Julie said that she was in a fight. The clerk insisted that Julie not drive. The clerk allowed her to use the telephone and Julie called her parents. Mr. and Mrs. Grey arrived at Marathon to assist. Mr. Grey took the children back to his house and Mrs. Grey drove Julie to Geauga/University Hospital for medical treatment.

Deputy Sulak went to Marathon at Mayfield and Aquilla Road to meet with owner, Jim Mansour. Jim stated that he noticed that a female was having difficulty using the gas pump. Jim went out to the pump to assist. Jim observed that the female was visibly shaken and appeared haggard and the three children in the back seat were very upset and crying. Jim asked if the female was all right and she said that she had just been in a fight. Jim asked her where she was going and she said that she had to get to the Sheriff's Office. Jim told the female that he was not going to allow her to drive and asked her to follow him into the store so she could call someone to come and assist her. The female used the phone and called her parents. Her parents responded to Marathon. Her father took the children back to their home while the mother drove her to Geauga Hospital. The female was later identified as Julie Grey.

Julie also stated that this is not the first physical altercation that has occurred between her and Tom. Julie stated that she and Tom fight at least once a week and several of the fights are physical. Julie indicated that she has fought back in the past where she has struck Tom. This is the first reported incident. The frequency and severity of the fights is what prompted Julie to want to finally leave.

Deputy Sulak photographed Julie's bruises/injuries and obtained her written statement (SEE ATTACHED).

Julie signed a medical release form and the emergency room documents are included with this report (SEE ATTACHED).

Julie signed a motion for temporary protection (SEE ATTACHED).

Nurse Carol Lee contacted WomanSafe and reported this incident.

At 0855 hours, Sgt. Nichols arrived at the hospital and spoke with Julie. After Julie stated that her head was pushed into the wall and then into the washing machine, Sgt. Nichols asked permission to search her home to further investigate the scene upon taking Tom Lane into custody. Julie granted permission and signed a permission to search form (SEE ATTACHED). Julie advised that Tom could possibly be located at his parent's house on Wilder Road, Chardon Township, if he was not found to be at home.

After leaving the hospital, Sgt. Nichols drove past 13791 Mayfield Road and did not observe Tom's vehicle in the driveway.

At 1109 hours, Deputy Sulak, Deputy Filby, Sgt. Nichols and Lt. McCaffrey responded to 9890 Wilder Road,

Chardon Township, in search of Tom Lane. Before deputies arrived at the above location, dispatch received a call that Tom Lane arrived home. Deputies responded to Mayfield Road location and arrived 1133 hours.

Deputy Sulak and Deputy Filby took position at the front of the house while Sgt. Nichols and Lt. McCaffrey, with K-9 Brutus, took positions at the rear of the house. Deputy Filby called the house telephone and the answering machine took the call. Sgt. Nichols then advised that he could observe Tom through the window. Tom was tapping on the window in view of Sgt. Nichols to acknowledge he was aware of deputy's presence. Sgt. Nichols ordered Tom to exit the house. Tom stated he had to put on his pants. Tom soon exited the house and was taken into custody without incident. Deputy Filby transported Tom to the Sheriff's Office.

Deputy Sulak and Sgt. Nichols entered the house through the back door to observe the damage that Julie reported was caused during the incident. Deputy Sulak went into the kitchen and observed a large round hole in the wall. Several strands of long hair were found hanging around the edges of the broken dry wall. The hair was taken as evidence and the wall photographed.

Deputy Sulak and Sgt. Nichols continued to inspect the interior of the home and observed it to be in disarray. Upon entering the laundry room, a black rubber utility hose was observed to be stretched across the utility sink and the end of the hose inside the opened washing machine. There was approximately 3-5 inches of water in the washing machine along with a small amount of clothing. A photograph was taken of the washing machine.

Deputy Sulak arrived at Post 1 to allow Tom Lane to make a statement. Tom was in the booking cell of the jail. Tom was given his Miranda Rights in the presence of Corrections Deputy Fletcher and advised of his charges. Tom was given copies of his Rule 4 charges. Tom signed his rights form and stated that he wanted to speak to his attorney, Robert Wantz, before continuing. Tom was permitted to use the phone and he contacted Robert Wantz. After being advised by his attorney, Tom stated that he did not want to answer questions and would not give a statement. Deputy Sulak then left the jail.

The two strands of hair collected at the scene were entered into evidence.

Two Rule 4's were completed and will be sent to Chardon Municipal Court. Tom Lane is being charged with O.R.C. 2905.01 (A-3) Kidnapping, a Felony of the First Degree and O.R.C. 2903.11 (A-1) Felonious Assault, a Felony of the Second Degree.

On 4-6-02 at approximately 0742 hrs. Deputy Spangenberg received a page from the Geauga County Dispatch Center. The page requested Deputy Spangenberg to contact the dispatch center in regards to a domestic violence victim currently receiving treatment at UHHS Geauga Regional Hospital.

On the above date, at approximately 0750 hrs. Deputy Spangenberg contacted the Geauga County Dispatch Center and spoke with Dispatcher Daily. Dispatcher Daily advised Deputy Spangenberg that the victim, Julie Grey, had been strangled and severely beaten by her ex-husband, Thomas Lane. Dispatcher Daily advised that Deputy Spangenberg was not needed to respond to the hospital. The page was only to make Deputy Spangenberg aware of the case.

On 4-6-02 at approximately 1828 hrs., Deputy Spangenberg spoke with Ms. Grey via telephone. Arrangements were made for Deputy Spangenberg and Ms. Grey to meet the following day, 4-7-02, at the Geauga County Sheriff's Office.

On 4-6-02 Deputy Spangenberg contacted Cope-line and requested to speak with the on-call social worker for Geauga County Job and Family Services. Deputy Spangenberg received a call back from SW Michelle Warren. Deputy Spangenberg briefly explained what had taken place at the Lane/Grey residence with the three children present, witnessing a small part of the assault. SW Warren was advised that Mr. Lane was in custody and would remain at the Geauga County Safety Center until his court hearing on 4-8-02. SW Warren was given a telephone number where Ms. Grey could be contacted.

On 4-7-02 at approximately 1655 hrs., Deputy Spangenberg met with Ms. Grey at the Geauga County Safety Center. Deputy Spangenberg observed Ms. Grey's body movements to be very stiff. Ms. Grey advised Deputy Spangenberg that her head and neck were very sore and she felt light headed and dizzy. Deputy Spangenberg asked Ms. Grey if she felt she needed to go back to the hospital. Ms. Grey stated no, however the doctor did tell her to go back if she became dizzy for a long period of time. Ms. Grey also advised Deputy Spangenberg that the emergency room doctor had advised her that the broken veins in her eyes were caused from being strangled. Deputy Spangenberg observed numerous bruises on Ms. Grey's person. The injuries Deputy Spangenberg observed are as follows;

- large bruises to the left back upper arm and left back shoulder
- bruising to the left elbow
- small cut with a bruise around it on the left forearm
- a small cut to the left wrist
- large bruise on the right inside upper arm
- two round circular bruises on both sides on the chest, yellow in color
- three bruises under the chin, deep red in color
- bruising to the left hip bone
- large bruise to the left side of the left knee
- bruising to the corner of the left eye
- broken vein in the left eye
- small bruise on the right eye lid
- left hand was slightly swollen and bruised near the first knuckle of the index finger
- right foot swollen and bruised near the small toe

Deputy Spangenberg photographed the injuries described above.

On 4-7-02 at approximately 2045 hrs., Deputy Spangenberg faxed a copy of the initial report to the Geauga County Prosecutor's Office and Geauga County Job and Family Services. Deputy Spangenberg then contacted
