(C) SUMMARY AND INTRODUCTION: EMBASSY RECEIVED ON MAY 18 A HAND WRITTEN LETTER ADDRESSED TO AMBASSADOR CASTRO PURPORTEDLY FROM THELMA DOROTY JARA DE CABEZAS POSTMARKED FROM SAO PAULO BRAZIL ON MAY 5. SRA. JARA DE CABEZAS, SECRETARY OF THE COMMISSION OF FAMILIES OF DETAINED AND DISAPPEARED PERSONS (FDD), WAS REPORTED DISAPPEARED ON APRIL 30 AFTER VISITING HER HUSBAND IN A CANCER CLICC. SHE HAS NOT BEEN SEEN SINCE; HOWEVER, FDD ACQUAINTANCES REPORTEDLY HAVE RECEIVED LETTERS FROM HER POSTMARKED FROM URUGUAY AND BRAZIL AND AT LEAST ONE PHONE CALL FROM HER ATTESTING TO HER GOOD HEALTH. AT FIRST DUBIOUS ABOUT THE AUTHENTICITY OF THE LETTER SHE RECEIVED, MRS. CABEZAS' MOTHER REPORTEDLY CONCLUDED THE HAANDWRITING WAS HER DAUGHTER'S -- WHICH DOES NOT, OF COURSE, FULLY ADDRESS THE QUESTION OF THE CIRCUMSTANCES OF ITS PREPARATION, OR THE SECRET

LETTER RAISES SEVERAL QUESTIONS. END SUMMARY AND INTRODUCTION.

2. (C) IN THE LETTER, MRS. JARA DE CABEZAS FIRST COPIED A LETTER SHE CLAIMS TO HAVE SENT TO PRESIDENT VIDELA. BUENOS AIRES ARCHBISHOP MONSGR. ARAMBURU, AND THE PERMANENT ASSEMBLY FOR HUMAN RIGHTS. THEREIN SHE CONTENDS THAT IN HER GRIEF AS MOTHER OF A DISAPPEARED SON, GUSTAVO ALEJANDRO, SHE WAS DUPED INTO WORKING WITH SUBVERSIVE ELEMENTS WHICH SHE HAS FINALLY DECIDED TO EXPOSE AND REJECT. SHE DESCRIBES HER SOJOURN TO MEXICO ON JANUARY 2 AT THE BEHEST OF HER EXILED SON DANIEL, A MEMBER OF THE MONTONERO PERONIST MOVEMENT (MPM), WHO PERSUADED HER TO COLLABORATE WITH HIS MONTONERO COMRADES AGAINST THE GOVERNMENT THROUGH HER ACTIVITIES WITH THE FDD. IN MEXICO SHE WAS INTERVIEWED BY MPM ACTIVISTS IN A HOUSE ON CALLE EXTREMADURA NO. 323 OR 332. LATER, THE LETTER GOES ON, MRS. JARA DE CABEZAS MET WITH "CAPITAN" MARIA ANTONIA BERGER, WHO BROUGHT HER TO EUROPE ON MAY 10 TO MEET WITH MONTONERO COLLEAGUES. FIRST IN MADRID, SHE AND BERGER WERE REBUFFED IN ATTEMPTS TO MEET WITH A SPANISH CATHOLIC ARCHBISHOP AND UNSUCCESSFUL IN LOCATING METHODIST PASTOR LUIS POVEDA. LATER IN ROME THE POPE REFUSED TO RECEIVE MRS. JARA DE CABEZAS. HOWEVER, WHILE THERE SHE ATTENDED A WEEKLONG MEETING OF THE MONTONERO LEADERSHIP, INCLUDING MARIO EDUARDO FIRMENICH, OSCAR BIDEGAIN, JAIME DRI, (SHE NAMES 20 PERSONS IN ALL). AT THE MEETING THE MONTONEROS PLANNED THEIR "COUNTERATTACK" STRATEGY AGAINST THE ARGENTINE GOVERNMENT. SOME OF THE MONTONEROS, JAIME DRI AND RAFAEL LACUZZI, AGREED TO RETURN CLANDESTINELY TO ARGENTINA. SECRET

3. (C) AFTER THE ROME MEETING, MRS. JARA DE CABEZAS RETURNED TO MEXICO CITY TO MEET WITH REPRESENTATIVES OF THE MOTHERS OF PLAZA DE MAYO WHO HAD ARRANGED APPOINTMENTS WITH BISHOPS ATTENDING THE LATIN AMERICAN BISHOPS CONFERENCE IN PUEBLA. LATER, ACCORDING TO THE LETTER, BERGER GAVE HER INSTRUCTIONS TO CONTACT THE LIGA (LEAGUE FOR THE RIGHTS OF MAN, A COMMUNIST-FRONT HUMAN RIGHTS ORGANIZATION IN BUENOS AIRES) ON HER RETURN TO BUENOS AIRES.

- 4. (C) AT THIS POINT, MRS. JARA DE CABEZAS WRITES THAT SHE REALIZED HER CONTACTS WITH THE MONTONEROS WERE WRONG AND DESTRUCTIVE. SHE EMPHASIZES TO PRESIDENT VIDELA THAT SHE KNOWS HER LIFE IS AT STAKE AS THE MONTONEROS WILL NOT FORGIVE HER BETRAYAL AND SHE DOUBTS THE ARGENTINE GOVERNMENT WILL UNDERSTAND HER. SHE ASKS VIDELA TO WARN OTHER MOTHERS FROM BEING DUPED BY SUBVERSIVES AND RECOMMENDS HE END THEIR DISTRESS BY EXPLAIN-ING HOW AND WHY THEIR SONS DIED. THE MOTHERS, SHE SAYS, WILL UNDERSTAND AND FORGIVE. SHE ALSO ASKS VIDELA TO HELP THE MOTHERS FROM BEING MANIPULATED BY POLITICAL PARTIES SUCH AS THE COMMUNIST PARTY, (SOCIALIST) WORKERS PARTY AND MONTONEROS.
- 5. (C) AT THIS POINT THE LETTER IS DIRECTED TO AMBASSADOR CASTRO. MRS. JARA DE CABEZAS POINTS OUT THAT THE US GOVERNMENT IS ALSO MAKING POLITICAL USE OF MOTHERS' GRIEF WHICH COULD LEAD ARGENTINA TO ANOTHER BLOODBATH. SHE ASKS THE AMBASSADOR TO DO WHATEVER POSSIBLE SO THAT GOA WILL UNDERSTAND, IF IT CANNOT JUSTIFY, HER ATTITUDE AND CONDUCT.

THE LEGGER IS A FORGERY OR MORE LIKELY, THAT MRS. JARA DE CABEZAS WAS COERCED INTO WRITING IT IN SOME ELABORATE PLOT TO THROW THE BLAME FOR HER DIS-APPEARANCE OR DEATH ONTO THE MONTONEROS. OUR SUSPICIONS ARE SUPPORTED BY RECENT REMARKS REPORTED TO US MADE BY INTERIOR MINISTER HARGUINDEGUY TO THE EUROPEAN COMMON MARKET AMBASSADORS THAT, DESPITE EARLIER INDICATIONS OF HER BEING OUTSIDE THE COUNTRY, HE IS FOLLOWING LEADS INDICATING SHE WAS PICKED UP BYSELEMENTS OF THE MILITARY.

8. (S) INTELLIGENCE REPORTS ARE MIXED, SOME SUPPORTING THE THEORY THAT SHE LEFT OR WAS EXPELLED FROM ARGENTINA; OTHERS DISCOUNTING THAT SHE COULD HAVE LEFT OR BEEN FORCED OUT WITHOUT THE KNOWLEDGE OF ARGENTINE AUTHORITIES. WE UNDERSTAND THAT THE SECURITY FORCES HAVE BEEN ORDERED AT THE HIGHEST LEVEL TO LOCATE THE WOMAN. IT APPEARS IMPROBABLE THAT HER ALLEGED COMMUNICATIONS TO FRIENDS BY PHONE SECRET
