AFFIDAVIT OF Michael M Texter

On this 25 th day of April, 2018, Michael M Texter appeared before me, an individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Michael M Texter,

am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

1. While employed as a Clerk at United States Investigation Services, Boyers, Pennsylvania 16018 an OPM Affilate that conducts back ground checks whose Main Office is in Falls Church, Va.

Female co workers made suggestive sexual remarks for several months. Hostile remarks were also made such as:

"Why don't they just get rid of Him. Who cares whether He has a nervous breakdown and loses His house."

"Why doesn't He just do the world a favor and committ suicide."

"They are firing Mike Today I hope He screams and yells and makes a fool out of Himself."

One morniong when I arrived for the 6:00 a.m. shift My Female Team leader remarked, "Oh My God He is still here. I don't know what it's going to take to get rid of Him. They were suppose to put Him on workman's Compensation. He must need a Job pretty bad. I don't know how He ever passed a back ground check." As seen by the Female Felony Gang stalkers' in (2) One would wonder how the harassing Leadership/Management could have passed such a stringent back ground check.

2. Above mentioned (1) Daily hostilities resulted in the following flash Mob eruption on the afternoon 07/15/2005 Felony Gang stalking on Company time.

Several women came up behind Me while I was seated at My cubicle and made derogatory sexual remarks.

My Female "lead" loudly shouted out a sexual remark at the same time followed by another Female Who exhibited possible synthetic telepathy related to voice to skull technoloy.

The women screamed very loudly, "I hear the vocie of God!"

Another woman screamed loudly, "Somebody do something! They are taking over this place Maybe He is One of Them."

Absolutely nothing was done to quite this mob and based on prior Four Months of harassment I had no reason to beliee anything would be done.

- 3. I was wire tapped by the Fox News morning show Fox and Friends as a Dish subscriber when I tuned in they targeted My 4th Amendment Pricacy Rights and profiled My Personal Life on the air.
- 4. Wire tapping mentioned in (3) and Gang stalking mentioned in (2) were both major factors in the May 2011 Gang stalking that occcured at My home outside My bedroom.

A large group of "Men" gatherd to make death threats along with threats of property damage. Accused Me of being afraid of going outside because They wern't "women."

Stalkers included My only Brother and a nephew along with neighbor Hutchinson. Stalkers mentioned Rush Limbaugh and Pittsburgh radio jock Quinn blaming Me for losing 1/2 of their 401K.

Subsequent Outdoor harassment by neighbor Hutchinson in Days following this along with:

sand being poured into My Pick Up Truck gas tank

Dawn to Dusk light shot out

Filming Me out in My Yard

I was forced to sale My Home of 16 Years.

I have reason to believe They sabotaged My Septic System just prior to Sale and closing of My House.

I did retain Legal Counsel over neighbor Hutchinson threatening to sabotage a shared/deeded Septic access.

I also asked My Lawyer to file against Fox News mentioned in (3) at this time as I believe their Wire tap of My Dish Network address violated My Constitutional Rights Profiled My privacy as an Individual and Led even My inner Family to Believe they could entrap Me on My Own Property by forcing Me Outdoors with the intention of provocing Criminal charges against Me if I chose to defend Myself verbally or otherwise. Obviously none of the Gang stalkers` Beleived there would be any adverse consequences in surrounding My House after dark.

On a follow up visit to My Lawyer I inquired if He had Filed charges against Fox News on My behalf.

My Lawyer told Me No.

I am also a "Small Entity" # US 8,901,421 B2 Patent holder issued Dec. 2,2014 and considerable Public damage has been inflicted upon Me in My Personal pusuits by these Rating Jocks such as Quinn/Limbaugh and others.

Obviously I have been black listed and also blind sided as to whether any suits have been Filed on Mybehalf whether over Fox News or My Prosecution of My Patent at great personal expense.

I may have suits Filed if indeed that is possible without My knowledge.

5. As a result of (4) I lived 6 Years within Briarwood Manor Apartments in Titusville, Pa. 16373 /6354

USDA managed Public Housing owned by "Private Investors"

I experinced Gang stalking by an Obese perpetrator Mike Wagner who was a tenant in a separate building.

The leasing Manger was made aware of Wagner but refused to evict or ban the stalker from the property.

Leasing Manger allowed systematic harassment along with Drug Raves ,bouncing objects off walls and striking My walls hard enough to knock objects off the wall., running up and down stairs.

Wagner's behaviour including knocking on doors at 5:30 A.M. along with verbally declaring His presence.

Following Me into Grocery stores and wating for Me upon return and blocking Me in the parking lot and stairwells.

Entering Highway when I walking and had appointments.

I filed a report with Titusville Police Department about out the Wagner stalking and also made an additional call. Police Department informed Me that Wagner was not doing anything wrong.

Both Leasing Manger and Maintenace Man routinely entered My apartment to violate My Privacy. Maintenace Man repeatedly gatherd Info to use against Me in regards to the Social Security Administration. Maintenace Man also filmed Me from behind the trash dumpster.

On two occasions Tenants opened My USPS packages that were left in the hallway and removed the packing slips. The second time it happened the Tenant was not even evicted and went on to continually door knock neighboring apartment every time I entered My apartment.

Several Individuals stalked Me in the Titusville Get Go Gas station parking lot and yelled derogatory remarks about a Blog I had been posting to and about a UPS package that They "just seemed" to know I was to receive that day.

6. A death threat was made on Twitter platfrom when another user Tweeted to Me, "You need to take Your last breath."

Of couser I reported the threat to Twitter and they Emailed that it didn't Violate Their Community Standards.

7. My Computer was hacked along with My Credit Card with Me supposedly giving a\$66 donation to a school in the United Kingdom.

Needless to say I have been now forced into a rural site in October 2017 with no indoor plumbing alienated from all Family ties.

Far removed from the USDA Briarwood Manor and My Home of 16 Years in order to keep the small amount of Constituional Freedom I experience.

I declare under the laws of the United States and the State of Pennsylvania that to the best of my knowledge and belief the information herein is true, correct, and complete.
