AFFIDAVIT OF Cori M. Ramirez

On this 5 day of June, 2018, cori m ramirez appeared before me, an individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, cori m ramirez, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

1. my name is cori m ramirez. I have a 18hr early childhood education certification and a C.N.A. nursing certification. I am listed on the illinois dept. of public health nurses registry. I am a grandmother and a mother. I am currently retired due to disability.

2.1 currently live at

for the past 2 years. Previously i

lived at 3639 n pine grove ave. for 24 years where i raised my daughter.my family resided in that apt. for 48 years and that address is where my family and I became targeted individuals.including my granbaby since birth in the summer of 2014.

3 in the summer of 2014 on july 4th, I was looking out the windows watching the fireworks when i noticed a series of flashes coming from the windows from the building in front of mine. As i paid attention i could see several individuals standing in the window taking pictures in my windows. On oct.03,2014 when i noticed the flashes again i called 311 to file a police report #HY187843. The police report is for harrassment by electronic means. I never heard from the police to follow up on my police report. I was issued a victims information notice, but never any contact from the local police. On june 05.2015 i was chased down the block by 2 young men who were yelling we are going to kill you, i was able to turn around to see these men run into the back of the building at 615 w. addison, chicago,il,60613, i called 911 by the time the police came the men were gone. The police issued me a event number #1515619565 and told me if i saw them again to call 911.On july 20th,2015 i was walking home from the grocery store and again was chased my the same 2 young men this time they put a gun in my back and told me they were going to rape me and kill me.I called 911 and once again the men were gone by the time the police got there they issued me a police report #HY343787 for a simple assault. the picture taking in my windows got worse and i was always keeping my drapes closed. I then noticed people following me on the bike path were i walked everyday. finally i called the police to find out why they havent contacted me being i had 3 confrontations with these men by then, i was told my cases were suspended with no explanation of why.l called the independent police review board 2 file a complaint against the chicago police the board took my complaint and passed it to internal affairs. That

information has now disappeared off their computers showing ive never had contact with the review board or internal affairs. somebody removed those complaints off their system.about july 20th,2015 i went to the warrant officer to get a warrant for the men who have been threatening me,they wouldnt give me one. These men and several others started following me everywhere i went taking pictures it got so bad to the point i hired a private investigator on 03,04,2016 to investigate who the people were living at the address where they were taking pictures from . i also did a debugging. It didnt reveal too much so at that point i told my daughter to move out of the house.and at this point still none of my police reports were ever investigated.

4. In 2015 i started feeling alot of pain in my eyes and ears and my head. I started hallucinating and seeing different images I started getting sick to my stomach and was constantly dizzy i was off balance and falling. Then the genital pain started and it was so intense i would be doubled over and had to start taking ibuprofen 800 for pain the hallucinations got worse the pain got worse.I then started getting leg pain and felt as something was digging in my groin area, i felt as if i was being raped, and sodomized. the attacks got worse every day and then i started feeling burning on my skin and little electric shocks all over my body as if being electrocuted.my eyes at this point burnt so bad and i felt pain constantly, i started seeing floaters in my eyes the rape got worse every day that went by i felt as if my insides were falling out of me.I went to the gynecoligist who told me i had 2 inches of bladder coming out of me and i ended up needing surgery for bladder repair and rectal repair and a hysterectomy i was fine before these electronic rapes started happening over a period of 2 years i have so many trips to the doctors office and surgeries as well. 5.SURGERIES:

A. hysterectomy, bladder repair, and rectal repair

B.vascular surgery of my main vein in my right leg from the groin to below the calf

C. broken left foot, and then the foot was rebroke

D. emergency room visit at thorek hospital for burning in my nose i was told the inside of my nose was burnt

E.concussion, i was diagnosed with a concussion last year in 2017 and im still currently in physical therapy [due to a direct energy laser pointed at the middle of my forehead at all times]

- 6.My family: my family are targeted individuals as well but because of the graphic detail of the assaults, i must protect their identity at this time due to the fact my granbaby is a minor only 3 years old and my daughter as well. I will testify in court to the attacks on my family as well. they are enduring the same type of attacks as me.
- 7. Over the years from 2015 until present i have endured unbelievable pain, sexual assaults, sodimy, electrocution and burning of my skin. this is happening on a daily basis 24 hr a day. direct energy microwave weapons to my head, my temples, my whole body. they are using pshycotronic weapons as well which is causing my hallucinations. They control my central vision and i have implants all over my body. They stop me from breathing, they stop my heart they

stop me from urinating i am being catheterized on a daily basis, i wake up in the middle of the night choking they make me choke on food and stop me from swallowing they sleep deprive me daily, the magnification in my eyes is so strong i can barely keep my eyes open they put some type of little rocks in my nose which causes extreme burning my ears are ringing constantly they target my inner organs, i feel like im going to pass out all the time they have chipped me and threaded me as well. They have tried v2k on me but i listen to music to block out what im hearing i see what they want me 2 see they participate in child pornography and have no problem showing me those images i am sure i am leaving out many attacks not by choice but every day is different and a struggle to survive. I now write down everything as it occurs, but make no mistake when i say we are being tortured it is exactly that torture from electronic and psychotronic weapons.

8.In closing:

A.I know who my attackers are and where they live they are current and retire police, they are current and retired armed forces and their families including women and children[teenagers] who all have been taught to run these machines on us. there are atleast 60 people involved i can identify them as well in court or a line-up if given the opportunity. My attackers also know i know who they are which puts us at a bigger risk. I do have some pictures and will try to collect more. The gangstalking is also still current every time i step out of my house, my phone, 2 t.v.s and computer has been hacked.

B.I will not commit suicide,I will not give-up,I will strive daily to seek justice for my family,myself,and other t.i.s around the world.I am vigilant in my efforts ...
