CUBAN REVOLUTIONARY ACTIVITIES

ReMMairtel to the Bureau, 8-5-60, and enclosure thereto, and WFOairtel to the Bureau, 8-10-60, and enclosure thereto.

Transmitted herewith to the Bureau are nine copies and to Miami two copies of a letterhead memo dated and captioned as above.

On 8-24-60, Dr. EMILIO NUNEZ PORTUONDO, 1028 Connecticut Ave., N.W., Washington, D.C., furnished information to SAs JOSEPH E. SCULLY and JAMES CALVIN CONRAD as set forth in enclosures.

On 8-29-60, WF 1161 S and former WF 1205-PSI, who are familiar with some phases of Cuban activities in the Washington, D.C. area and who have furnished reliable information in the past, advised SA DONALD HOETING that they possess no information concerning any plan by any anti-CASTRO group in the U.S. to present a declaration denouncing the FRD and/or the U.S. before the OAS meeting which was held in Costa Rica.

Since WFO sources reported no information which tended to confirm possible action by Cuban exiles to present a declaration of denunciation of the FRD and/or the U.S. before the OAS meeting scheduled for 8-16-60, in Costa Rica and since the OAS meeting has terminated without any apparent attempt on the part of any anti-CASTRO group to present such a declaration, WFO contemplates no further action in this matter at this time and it is considered RUC.

The enclosed letterhead memo is classified "Secret" since the information pertains to an operation of CIA.
