Re New York letter to the Bureau dated March 23, 1962.

On April 6, 1962, BA CS 2 advised SA MYRON C. METCALF that Baltimore telephone number Wilkens 5-7161 is listed to HOWARD LANGFORD, 2407 Elsinore Avenue, who is identical with HOWARD DAVID LANGFORD, subject of New York File 100-59726, and who is also mentioned in New York File 100-117227. The Bureau file number on LANGFORD is 61-9070.

LANGFORD has been residing at Baltimore, Maryland, since 1958. From that time until 1961 there was no subversive derogatory information reported concerning him. In October, 1961, he became active in the Maryland Committee for Democratic Rights (MCDR) and since that date has been reported in attendance at numerous meetings and social affairs sponsored by the MCDR.

On March 20, 1962, BA 975-S advised SA ROBERT C. NORTON that on March 19, 1962, BOB LEE, member, District Board, Communist Party, Maryland - D. C. District, stated that HOWARD LANGFORD had recently come into a large sum of money and was planning to visit the Soviet Union in June of this year.

A characterization of the MCDR is enclosed herewith for the New York Office.
