

BlackRock Inc. has filed a 13G/A form with the Securities and Exchange Commission (SEC) disclosing ownership of 69,275,884 shares of UnitedHealth Group Inc (UNH). This represents 7.4 percent ownership of the company. In their previous filing dated February 1, 2021, the investor reported owning 71,592,885 shares and 7.50 percent of the company, indicating a decrease in



shares of 3.24 percent and a decrease in total ownership of 1.33 percent. The investor has filed 13 13D or G filings since February 8, 2012.
