Having before it the "Victims' request for reclassification of ICC-02/04-01/15-1887-Conf", of 8 December 2021 (ICC-02/04-01/15-1924),

# ORDER

The Registrar shall reclassify as public document ICC-02/04-01/15-1887-Conf.

### REASONS

#### I. PROCEDURAL HISTORY

1. On 4 February 2021, Trial Chamber IX (hereinafter: "Trial Chamber") convicted Mr Ongwen of crimes against humanity and war crimes.<sup>1</sup>

2. On 6 May 2021, the Trial Chamber, by majority, sentenced Mr Ongwen to 25 years of imprisonment with a deduction for time spent in detention between 4 January 2015 and 6 May 2021 (hereinafter: "Sentence Decision").<sup>2</sup>

3. On 30 August 2021, the Defence filed its appeal brief against the Sentence Decision confidentially (hereinafter: "Sentence Appeal Brief").<sup>3</sup> On 31 August 2021, a public redacted version of the Appeal Brief was filed.<sup>4</sup>

4. On 26 October 2021, the participating victims filed their respective observations on the Sentence Appeal Brief confidentially.<sup>5</sup>

5. On 6 December 2021, the Appeals Chamber, *inter alia*, ordered the Legal Representatives of Victims (hereinafter: "Victims Group 1") to file a public redacted version of document ICC-02/04-01/15-1887-Conf.<sup>6</sup>

6. On 8 December 2021, Victims Group 1 requested the reclassification as public of document ICC-02/04-01/15-1887-Conf (hereinafter: "Reclassification Request").<sup>7</sup>

#### II. MERITS

7. Victims Group 1 seek reclassification as public of the "Victims' Observations on the 'Defence Document in Support of its Appeal against the Sentencing Decision'" filed on 26 October 2021.<sup>8</sup> They provide that, pursuant to regulation 23*bis*(1) and (2) of the Regulations of the Court, the submission in question was filed as confidential since it was a response to a confidential Defence filing.<sup>9</sup> Further, they submit that document ICC-02/04-01/15-1887-Conf discloses no confidential information.<sup>10</sup>

8. Noting that no responses were made to the Reclassification Request and given the absence of confidential information in the aforementioned filing, the Appeals Chamber grants the request.

9. Accordingly, the Registrar is ordered to reclassify as public document ICC-02/04-01/15-1887-Conf.
