1 (Public) 23-0117008 DISTURBANCE

On January 17, 2023, at approximately 1020 hours, Officer McCain was dispatched to the Military Sciences building in reference to a disturbance. Prior to officers arrival, the subject causing the disturbance got into a white 2013 Toyota TC (LA/XGY534) and attempted leave the area. Officers were able to stop that vehicle and identified the subject as, David Lucito (non-LSU/ (337)326-9914).

Upon arrival to the Military Sciences building, Officer McCain contacted the complainant, student/ (a), who stated that Lucito entered the Military Sciences building and began talking about neuro weapons torture. He stated that Lucito was speaking with the Senior Enlisted Instructor and was very irate. Stated that someone inside building had a video of that conversation. Officers requested to see the video and it was presented without issue. In the video, Lucito is heard speaking of neuro weapons torture and their assault on him. Lucito can be heard stating his security clearance is above top secret, which he described as "medium rare", and that he knew more than the Senior Enlisted Instructor. Officer McCain attached the video to this report.

A short time before this call, Lucito spoke with Officer McCain and Detective Drake in the lobby of LSUPD about nano-technologies and neuro weapons torture. He stated that he had brought this complaint to many other agencies, including but not limited to BRPD and the FBI. He further stated the FBI was already investigating his complaint. He stated he had also called the Louisiana National Guard in the past and informed them of these weapons. Lucito stated he heard voices in his head and that was evidence of neuro weapons torture. Detective Drake advised Lucito that LSUPD could not investigate this complaint due to the FBI having an open investigation as Lucito stated.

After these interactions with Lucito, he was advised to not return to campus with this complaint of neuro weapons torture, as he was already advised by the FBI that they were investigating his complaint. He was further advised if he should return and cause another disturbance about this complaint he may be subject to a ban or arrest.

Officer McCain's body worn camera was activated for both the interaction in LSUPD lobby and while speaking with the complainant on this call.
