On January 17, 2023, David Lucito (DOB: **Construction**; Non-LSU) and Caroline Harris (DOB: **Construction**; Non-LSU) walked into the lobby of the LSU Police Department to make a complaint. I, Detective Drake, happened to be in the LSU Communications Office with the dispatcher who received David and Caroline. David being explaining to the dispatcher that he wanted to report that the government was using "micro technology" and micro waves" to control peoples minds and that the waves were currently being used on LSU's Camus to control he and Caroline.

After here the initial complaint, I went out to the lobby to talk with David and Caroline. Soon after contacting them, I would be joined by Ofc. McCain whose body camera recorded my interaction with the two complainants.

David and Caroline explained that they believe that the government is using "mind controlling technology" to control the thoughts and actions of them and the people around them. Both Davis and Caroline admit that they hear voices inside there heads that talk to them and give them instructions. When I asked if they were currently hearing voices, both responded "yes". Caroline even admitted that one of the voices was telling her to "talk to David". Caroline stated that she has reported the issue to the FBI Office in New Orleans and she even gave the names of several FBI agents that she has spoken to. One of those names, SA Whitney, I knew to work in the FBI NOLA branch. This made me think that they had been in communication with the NOLA FBI Office.

Caroline and David's grievance seems to be that the US Military isn't taking their complaints seriously. Both believe that the military should be launching and investigation or counter attack on the government for controlling the minds of the people in the local community.

During the conversation I was able to gather the following information about Davis and Caroline: David is originally from the pacific northwest, mainly Washington, but he has lived in Louisiana for the past few years. I check of David would later reveal that he had an address out of Opelousas, LA. David stated that he and Caroline, who he described as his girlfriend, recently moved to 3238 Carlotta St. Baton Rouge, LA 70802. During our conversation, David admitted that he has been committed several times, but he believes that ha is continuously being committed due to the government wanting to stop him from reporting the "mind controlling technology" and make him seem crazy.

I conducted a criminal history search of David and learned that he has a short criminal history consisting of: Criminal Trespass, Burglary, Cyberstalking, Harassment, simple possession marijuana.

A check of RMS showed that David has been contacted by law enforcement agencies in our area several times and has several report numbers related to being a missing person, being committed, and reporting the "mind control" to BRPD.

It is clear that David is suffering from mental illness which is affecting his reality and maybe contributing to some of the above-mentioned arrests and police contacts.

Caroline explained that she is from Morgan City, but she did live for a short time in the Carolina's. She explained that she was most recently homeless in Morgan City before moving to Baton Rouge. A search of Caroline's revealed that she is associated with an address out of Morgan City. 1229 Onstead St. Morgan City, LA 70380.

I conducted a criminal history search of Caroline and learned that she has one arrest: underage driving under the influence. I also found a BRPD report taken on March 31, 2016 wherein Caroline attempts to steal clothing from Dillard's in the Mall of LA. She was not charged with the attempted theft.

During the conversation with Caroline she speaks about how she is currently hearing voices that talk to her. It seems that Caroline is also suffering from mental health issues and that her reality may also be altered. After listening to David and Caroline's complaint, the two left the PD lobby. I explained that due to jurisdictional issues, LSU PD would not be able to field their complaint. After leaving the lobby, both went over to the Military Science Building and made contact with military personnel there. Ofc. McCain responded to Military Science Building. Please see LSU PD report # 23-0117008 for details.

It is likely that Caroline and David will continue to cause disturbances on LSUs campus due to their mental health issues.

On January 17, 2023, I made contact with SA Whitney out of the NOLA FBI Office. Whitney explained that they took Caroline's complaint as a walk-in complaint and stated that they often get complaints of this fashion as walk-ins. Whitney stated that the FBI did not see Caroline as threating but also believed that she is suffering from a mental health issues. SA Whitney did not have any information on David.

I attempted to contact Randall Harris, who I am assuming is the father of Caroline, but after several phone calls I have not been able to make contact.

I have created a BOLO flyer that includes photos of David and Caroline along with a brief description of my interaction with them. The flyer will be sent to Captain Berry of the LSU PD Patrol Division so that he can share with the patrol division.
