## Y NOU HAVE THE RIGHT TO SPEAK OUT

Your guardian will help you to get access to **free assistance** (food, accommodation, showers, doctors, school...) and will ensure that your rights are respected


Professionals (police officers, lawyers, guardians, judges, doctors etc) are persons you can trust

A **guardian** or **social worker** will help making decisions with and for you

You have the right to a free interpreter

You have the right to a **free lawyer**, for example if you are accused of something during court proceedings or for asylum request





#### WHAT CAN THE POLICE DO FOR YOU?

The police are here to listen to you and protect you if you are victim of violence or forced to do something you do not want to do.

Police officers are reliable people.

The police will **NOT** cause you any harm.

You will **NOT** be punished for something that you were forced to do, even if it is wrong or against the law. But sometimes the police may not understand at first so speak to your social worker and lawyer for advice.

#### WHAT IS HUMAN TRAFFICKING?

You or one of your friends may be a victim of trafficking, without realising it.

Have you been in a situation in which you had to:

- have sex or perform sexual acts?
- **→ work** (for example, in someone's house doing housework or childcare, a factory or a restaurant)?
- → beg, steal or commit crime?
- ↗ grow, carry or deal drugs?
- remove your organs to sell?
- Repay a 'debt' by working or providing some other service? Have you/your family been threatened?

If you answer "yes" to one of these questions, you or your friend may be a victim of trafficking.

Human trafficking is a serious crime and an abuse of your rights. Talk to a professional you trust if you are concerned so they can help stop the abuse, and protect other young people.

RIGHT TO BE ACCOMPANIED BY A TRUSTED ADULT, RIGHT TO HAVE A FREE LAWYER,

IN ALL CASES, ASK THE POLICE TO EXPLAIN YOUR RIGHTS:

FREE MEDICAL HELP, AND A FREE INTERPRETER

#### WHAT WILL YOUR GUARDIAN DO FOR YOU?

7 In the Netherlands.all children without legal caregiver α are appointed a quardian until they are 18 years old.

Your quardian will ensure that decisions about your care and protection are taken in your best interests.

Your quardian will help you to get access to medical and psychological care, to school and to appropriate accommodation.

Your guardian will also support the process of your application for a residence permit and will be there 

#### **INTERPRETERS**

7 You have the right to a professional interpreter, free of charge, during court proceedings and police interviews. You are always asked whether you prefer a male or female interpreter. If you do not feel comfortable with your interpreter, you can ask to your guardian to change. It is important for you to know that your interpreter must respect the confidentiality of your exchanges.





#### **I AWYFRS**

- In The Netherlands, as a child, you have right to a

   free lawyer.
- ▶ If you are victim of trafficking, a lawyer will appointed by the Legal Aid Board (Raad voor Rechtsbijstand).
- Nidos, the guardianship authority for separated children, can also find a lawyer for you.

How confidential is the information shared with the lawyer?

■ The information you will share with your lawyer is generally confidential. However, information in an asylum claim may be shared, although not with the government from your country of origin. In the same information regarding a trafficking can be shared with the police, but only to protect you.





# HEALTH



- If you stay legally in the Netherlands, you have access to a free doctor, with whom you can discuss your health issues.
- If you are not staying legally in the Netherlands, you only have the right to necessary free medical care.
- Your guardian will ensure that you receive the medical care you need.

Your guardian or immigration lawyer can inform you about your options. It can be a very long and complicated process.

If you are from another country, you may need permission to stay here. This may mean you have to apply for asylum or a residence permit to remain in the Netherlands. You can apply for asylum at the border or at any point thereafter with the help of your guardian and lawyer.






#### **EDUCATION**

What are the conditions of access to school?

◄ In the Netherlands, all children (below 18 years of age) have free access to education. Your guardian will help you to find suitable education.

But remember, you do not need official documents or immigration status to benefit from the child protection system.
