At the last council meeting, concerned citizens one after the other, made a plea to the city council and the Mayor Jamie Mayo for increased security at neighborhood recreational and retirement home centers. The conversation was a virtual repeat in council chambers Tuesday night. City Councilman Kenneth Wilson(dist. 4), as he did at the last council meeting asked the administration if safety features could be enhanced at the recreational centers following the shooting of a teen after an argument started between other parties. Foster Wilhite, known as "PPW" in the community, once again pleaded with council members to support Wilson. This time Wilhite was accompanied by his grandson, the young man who was shot in the leg. The teen can walk slowly with the aid of crutches while the bullet is still in

his leg. Doctors, accord-

ing to Wilhite said that they will not operate at this time, hoping that the bullet "can work" its way out. Wilson said that he talked to City Marshal Wince Highshaw, who said that he is willing "to work with the council" in any way that he can. Wilson said that he is in contact with the mayor and others in an effort

be done to protect "our young people". Wilson is on record as saying that in addition to security on the ground, he said that metal detectors would also be helpful.

"The upcoming election in November is an opportunity for much needed economic development to come to the south side", said Councilman (Dist. E) Eddie

Clark, who was instrumental in getting the Bond Commission to place a 2% hotel tax on the ballot, if passed in districts 3, 4 and 5, voters in those three districts will receive money through the South Side Economic Development District, an organization that will spearhead economic growth on the south side.


The presence of a conscience allows man to determine right from wrong. This is essential in man's carrying out his responsibilities to his children and children of others.



# Remembering the Dead

With each passing day,

the memory of those 58 people killed by a lone gunman in Las Vegas will become just that—a memory. Why do we become so passionate over some issues like the so-called flag protests that seem to linger on and on, but not over the Las Vegas shooting? Is it because none of us was affected, but by the same token, we sympathize with the victims? Why is it that so many of us want to rally around the flag over an issue that has nothing to do with disrespect, but will turn a blind eye to an issue that is about life and death? Those are hard questions whereby the answers seem so ever elusive. There are mass killings that occur in the U.S. more frequently than we know about, but other "newsworthy" issues take center stage. There is this daily obsession with what the president is doing/ saying, than to what matters to most of us. Many of us have "bread and butter" issues such as keeping our jobs, paying bills and taking care of our families. It could be accurately said that the thousands of people who attended that concert/festival in Las Vegas may have had some of those issues in their lives. Nonetheless, for just a few hours they did what we all do, that is to do something that gives us a little pleasure in life for just a little while, knowing that we have to face the real world when it is all over. Fifty-eight people out of the thousands who were at the festival, including police officers will not live to talk

minutes when the shootings occurred.

There is one person who also survived a shooting, that had it not been for law enforcement officers present, he could have been a victim of a mass shooting. Louisiana's congressman Steve Scalise was seriously injured back In June, as he and other congressional representatives were practicing for an annual baseball game. If not for the quick action of Capitol Police and others, Congressman Scalise could very well be a memory by now. The congressman survived the shooting (the gunman was killed) and spent months recuperating from his near fatal injuries. Now he is back in Washington. When Mr. Scalise was shot, the conversation quickly turned to "doing something" about guns. However Mr. Scalise being a staunch supporter of gun rights (as is this reporter), but not to the point of guns that are of military grade, did not alter his views after he was almost killed, and not after the Las Vegas massacre. No matter how many people that have been killed in mass shootings by guns that are not used for sport/hunting, Republicans steadfastly refuse to consider any gun legislation. There was a glimmer of hope following what happened in Las Vegas, but that seems

Congressman Scalise penned a "thank you" letter to those who "prayed and extended" well wishes to him and his family. He talked about God's grace allowing him to live. He talked about being with his family, especially his children. He also talked about his faith in God. He also said that his near death experience "changed his life forever, but not the way you might think". It would appear that the congressman was given an opportunity by God's grace to make a change in the guns conversation, but he will not use that voice to do so. Why we may ask. Carroll. Julian excelled at football, becoming Co-Captain of the football team during his junior year, and then Captain during his senior year of high school. While excelling in sports, Julian kept up his studies and maintained honor roll status throughout high school. On the team, he played tight end very well, and was an All-State Football Player, catching 16 touchdown passes in his junior year and 13 touchdown passes in his senior year. During his time at Carroll High School, the Bulldogs won their first State Championship in 1961 under the tutelage of Coach J.L. Thomas. Upon high school graduation Julian quickly set his sights on furthering his education and playing "ball". In 1962 Julian was awarded a full athletic scholarship and entered Grambling College, now known as Grambling State University. Following beside him was his high school sweetheart and longtime love, Geneva Lynch.

Under the training of the legendary Coach Eddie Robinson, Sr., Julian and a multitude of teammates were destined for greatness. Despite heavy football training and coursework, during the holidays and summer breaks, Julian came home to work with his father at The Bayou De-Siard Country Club, to earn extra money. say that Marquinton produced a gun, whereby he was shot and killed. Underwood was apprehended with drugs and a firearm in his possession. The third passenger wasn't harmed, but was said to collaborate deputies' account of the inci-

The incident happened about 5:30p.m. that afternoon. At about 5:41p.m., the family received a call that Marquinton had been shot, and told the family where he was. Several members of the family hurriedly drove to the area where the incident happened, only to be asked by officers at the scene at a roadblock, "how did they know" of the incident. They were told "to wait", but from their vantage point, they didn't see or hear any emergency vehicles come to the area, but only saw law enforcement vehicles. As the family asked more questions, they also noticed that there wasn't any yellow tape at the scene, but didn't get any answers, only questions about who they were. The family felt that the officers in charge treated them in a manner that was unprofessional, given the stress that they were under, not knowing if their loved one was dead or alive. The family thought that if the officers knew that they were related to Marquinton, and they knew who they (deputies) shot, just tell them if it was their loved one. The father, along with Marquinton's mother and grandmothers were there, but still the family had to wait hours before they finally got confirmation that Marquinton "was deceased", allegedly telling them that he had "drugs and a gun" on him, nothing else. The family contends that throughout their ordeal, the treatment that they received was crude and abusive. The family

A RESOLUTION CERTIFYING THAT THE DAM-AGE/COLLAPSE OF A PORTION OF COMANCHE TRAIL RESULTING FROM A RUPTURED WATER MAIN CON-STITUTES A "PUBLIC EMERGENCY" PURSUANT TO LA. R.S. 38:2212(D)(1)(a); AND, FURTHER PROVIDING WITH RESPECT THERETO

WHEREAS, on the evening of Friday, September 8, 2017, a large, high pressure water main ruptured under Comanche Trail, just north of Indian Lake Drive;

WHEREAS, water rushing from this ruptured main significantly damaged the road bed and roadway rendering a section of the roadway approximately 200' in length collapsed or otherwise impassable;

WHEREAS, this damage to Comanche Trail has cutoff direct vehicular access to dozens of homes. A detour is available to allow vehicles to reach all but a few of these homes; however, that detour involves placing significant traffic on two particularly narrow, curving residential streets that were not designed or intended for such traffic;

WHEREAS, residents in the immediate area of the collapsed roadway are unable to reach their homes by vehicle: and.

WHEREAS, the Ouachita Parish Police Jury finds that the consequences of the sudden and unforeseen event that rendered this section of Comanche Trail impassable constitutes a "public emergency" under La. R.S. 38:2212(D)(1)(a)

### NOW, THEREFORE:

BE IT RESOLVED that the Ouachita Parish Police Jury hereby certifies the sudden and unexpected rupture of a large, high pressure water main under Comanche Trail that occurred on or about September 8, 2017, which damaged a portion of that roadway to the extent that it is impassable, to constitute a "Public Emergency" pursuant to La. R.S. 38:2212(D)(1)(a);

BE IT FURTHER RESOLVED that a Notice of this Public Emergency shall be published within 10 days in the Official Journal of the Ouachita Parish Police Jury. The above resolution was adopted the 15th day of Sep-

tember, 2017.

Motion offered by Mr. Caldwell, seconded by Mr. Robinson to accept the lowest conforming bid and award the contract to Amethyst Construction, Inc. Motion passed without opposition.

Subject to the approval of the Louisiana State Bond Commission, and under the authority conferred by Article VI, Sections 29, 30 and 32 of the Constitution of the State of Louisiana of 1974, the applicable provisions of Chapter 5, Chapter 6-A and Chapter 6-B of Title 18 of the Louisiana Revised Statutes of 1950, as amended, Chapter 27 of Title 33 of the Louisiana Revised Statutes of 1950, as amended and other constitutional and statutory authority, a special election is hereby called and ordered to be held by the District on Saturday, November 18, 2017 between the hours of seven o'clock (7:00) a.m., and eight o'clock (8:00) p.m., in accordance with the provisions of

La. R.S. 18:541, and at said election there shall be submitted to all registered voters qualified and entitled to vote at said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

Shall the East Ouachita Economic Development District, State of Louisiana (the "District"), under the provisions of Article VI, Sections 30 & 32 of the Louisiana Constitution of 1974, as amended, and other authority, be authorized, and to adopt an ordinance, to levy and collect, a sales and use tax of one and thirty-nine hundredths percent (1.39%) on sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales and services within the District, as defined by law, inclusive (the "Tax") (an estimated \$2,650,000 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of twenty-five (25) years, commencing effective April 1, 2018 and shall the proceeds of said Tax (after paying the reasonable and necessary expenses associated therewith) be dedicated and used for the purpose of undertaking economic development projects consisting of, but not limited to, road, drainage, related infrastructure projects and improvements, and securing and paying bonded indebtedness for the aforementioned purposes, all for benefit of the District?

SECTION 2. Publication of Notice of Election. A Notice of Special Election shall be published in the

"Ouachita Citizen", a newspaper of general circulation within the District, published in Monroe, Louisiana, and being the official journal of the Governing Authority, once a week for four (4) consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date fixed for the election, which Notice shall be substantially in the respective forms attached hereto as Exhibit "A" and incorporated herein by reference the same as if it were set forth herein in full, with such changes as may be necessary to be made at the discretion of the Chairman, Secretary or such other representative of the District as shall have the apparent authority to make said changes (the "Authorized Representative"). As of the adoption of this resolution, the registrar of voters was unable to provide a list of polling places for the District. Once that information is received, the Authorized Representatives are hereby directed to complete the Notice by including said information, prior to publication.

SECTION 3. Canvass. This Governing Authority shall meet at its regular meeting place, at Police Jury Meeting Room (2nd Floor - Ouachita Parish Courthouse), 301 South Grand, Monroe, LA, on MONDAY DECEMBER 4, 2017, at 5:30 P.M., and shall then and there in open and public session proceed to examine and canvass the returns and declare the results of the said special election.

SECTION 4. Polling Places. The polling places set forth in the aforesaid Notice of Special Election, as published pursuant to Section 2 hereof, are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5. Election Commissioners; Voting Machines. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held on December 4, 2017, as provided in Section 3 hereof. All registered voters in the District are entitled to vote at said special election and voting machines shall be used.

SECTION 6. Authorization of Officers. The Authorized Representative is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the Authorized Representative is further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the

SECTION 7. Furnishing Election Call to Election Officials. Certified copies of this Resolution shall be forwarded to the Louisiana Secretary of State, the Clerk of Court and Ex-Officio Parish Custodians of Voting Machines in and for the Parish of Ouachita, State of Louisiana (the "Parish"), and the Registrar of Voters in and for said Parish, as notification of the special election herein called in order that each may prepare for said election and perform their respective functions as required by

SECTION 8. Employment of Bond Counsel. It is recognized, found and determined that a real necessity exists for the employment of bond counsel in connection with the election; accordingly, Boles, Shafto & Leonard, LLC, located in Monroe, Louisiana, is hereby employed as Bond Counsel to perform comprehensive, legal and coordinate professional work with respect to the election. Bond counsel shall (i) prepare and submit to the District for adoption all the proceedings incidental to the election; and (ii) counsel and advise the District with respect to the election. The fee to be paid Bond Counsel for work on this election shall be an amount equal to the Attorney General's then current Fee Schedule for hourly rate work only and other guidelines for comprehensive, legal and coordinate professional work, together with reimbursement of out-of-pocket expenses incurred and advanced in connection with the election, said fee to be payable by the Commission subject to the Attorney Gen-

eral's written approval of said employment and fee. SECTION 9. Additional Notice Requirement. This Governing Authority made the announcement with respect to the adoption of the Original Resolution required by La.
