SUBJECT: Louisiana Medicaid Pharmacy Clotting Factor Products Update

Effective February 1, 2024, the Louisiana Medicaid Fee for Service (FFS) Pharmacy Program and Managed Care Organizations (MCOs), will change the reimbursement methodology for clotting factor products. Clotting factor products administered in an outpatient setting will only be reimbursed as a pharmacy benefit, not as a medical/professional benefit. This policy applies to outpatient claims submitted to FFS and MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and UnitedHealthcare).

Policy

Clotting factor will be reimbursed as an outpatient pharmacy claim based on a NDC-specific Average Acquisition Cost (AAC) plus a professional dispensing fee of \$0.03500 per unit dispensed.

Billing

Reimbursement to pharmacy providers for clotting factor products, excluding Hemlibra, will be based on the lower of the following:

- AAC, plus a professional dispensing fee of \$0.03500 per unit dispensed; and
 - o If no AAC rate exists, then Wholesale Acquisition Cost (WAC) + 0%, plus \$0.03500 per unit dispensed.
- Provider's usual and customary charge to the general public.

NOTE: Reimbursement of the professional dispensing fee of \$0.03500 per unit dispensed will have a maximum limit of \$1,676.22 per dispensation.

For ingredient cost, Myers and Stauffer, LLC will set an Average Acquisition Cost (AAC) per unit of factor dispensed based on a survey of Louisiana pharmacy invoices.
