## Early preparation is key as busy hurricane season predicted

In light of the start of what's expected by experts to be a very active hurricane season, it's as important as ever for Louisiana residents to be prepared for any danger a potential major storm could cause.

The St. Charles Parish government has a comprehensive hurricane preparedness guide available on its website - st-charlesparish.gov - to assist residents in getting a plan together for the season.

Jason Tastet, the parish's Director of Homeland Security and Emergency Preparedness, said it's very important that residents do not procrastinate – the best way to get ready, in this case, is to stay ready.

"Have an evacuation plan for the whole family, including pets, and gather important documents in one place," Tastet said. "Residents should prepare their homes before a storm enters the gulf by clearing tree limbs, debris and other items that could become projectiles in high winds."



Staying ready includes being set to leave town if an evacuation order is called for.

"Residents must not wait until the last minute to prepare or to leave town," Tastet said. "Those who choose to stay after an evacuation order is called put our emergency responders in a difficult and dangerous position, so we implore residents to leave when parish officials call for an evacuation. Having a generator at your home does not mean you should ignore evacuation orders."

#### Community rallies around Norco family who lost home in fire

Leonie Agurcia awoke to a noise heard outside, shortly after midnight, and what she saw moments later was terrifying.

"We woke up to something hitting my window," she recalled. "I lifted my head and thought it must be hail. I looked out the window and saw fire."

Agurcia's home caught fire on that May 14 night and she sprung into action as her family was in danger.

"I ran back to the bedroom and that's when we realized it was our house," she said. "I went to wake the kids up and get them out of the house ... we ran outside, across the street and called 911."

She acknowledges they were lucky to escape without injury or worse. Nonetheless, much was lost that night for the Norco family as their Goodhope Street home burned, as well as Agurcia's Taboe

"It was very devastating to watch. While standing out there waiting for the fire department, a million thoughts and emotions were running through my head," she said.

The family lost everything in the fire. Compounding the difficulty of the situation was that it came days before Agurcia's daughter Makayla's graduation from Destrehan High School.

"I wasn't just sad and upset about the fire, but it was graduation week for my daughter. It's been rough and emotional," Agurcia said.

Makayla said graduation was a bit of a blur.

"Walking across the stage

knowing I had nothing to go home to was kind of hard," she

She added, however, the support she received was greater than she could have imagined, both for graduation and to help her family getting back on their feet.

"All of my graduation stuff was gone. I had graduation in four days, and I didn't know what to do. Somebody did my hair, my makeup for it ... so many people offered me different outfits, dresses," Makayla said. "(To everyone who offered support) thank you for being there, for making sure we had everything we need to even live, it's amazing."

Agurcia said it's unclear what started the fire. That Monday night, an onset of severe weather hit the area and shortly after that cleared, the fire started. Agurcia said when she looked out the window, everything was bright orange.

Makayla said it was likewise scary for her.

"That was my mom and dad's room ... if they wouldn't have made it, I don't know how I'd have got through," Makayla said. "It came quick and it scared all of us. I just feel lucky we made it out."

As difficult as it's been, Agurcia said the support from others has been unreal and has provided a lift for the family, noting donations of kitchen items, clothing and monetary assistance. #### **Deputies forced to shoot armed man in response** to domestic violence call, Sheriff's Office says

St. Charles Parish deputies say they were forced to shoot a man in Bayou Gauche Sunday night after responding to a domestic violence call.

A woman had called the Sheriff's Office around 9:26 p.m. to report that her boyfriend, Dalton Todd, was holding a gun to her head. Deputies arrived on the scene, positioned themselves outside the home and asked for the 26-year-old Todd to come to the street.

Sgt. Jenni Barrette, spokeswoman for the Sheriff's Office, said Todd emerged with a gun and refused to disarm himself. Barrette said deputies then used "less-than-lethal" beanbag rounds to subdue Todd.

These rounds stunned Todd, but once he regained his composure he ran toward deputies with his gun pointed at them.

Barrette said that deputies once again gave Todd numerous commands to disarm himself, but he refused and began approaching the deputies.

When he was about 15 yards away, Barrette said deputies opened fire and struck Todd at least three times. After he was shot, deputies applied tourniquets to stop the bleeding.

Todd was airlifted to University Hospital where he is in stable condition.

According to the Sheriff's Office, Todd has an extensive criminal history dating back to 2014 that includes drug and domestic violence charges, violations of protection orders, theft and DWI.

Once Todd is released from the hospital, he will be booked on an active warrant for aggravated assault with a firearm, five counts of aggravated assault against a peace officer, and resisting an officer with force of violence.

#### **BLOOD DISORDER from 1A**

Six years later, Demi traveled from Luling to London to meet the man who saved her life.

Robert Brookes-Wardle, a British Army private, was 20 years old when he was contacted by DKMS, the world's largest blood stem cell donor center. He was informed that he was a match for a baby girl fighting for a second chance at

Brookes-Wardle had joined the national blood stem cell registry when he was 18 after hearing about it at one of the blood drives he routinely participated in.

"There was a bit of hesitation; I wasn't expecting to get matched with Demi, and I didn't do that much research into the donation process," Brookes-Wardle said. "So, after DKMS contacted me, I took the weekend to do my research and read stories about people that had donated as well, which all led me to donate."

Demi received her transplant on March 1, 2018. Her mother, DeeDee Thibodeaux, said Demi's health is "perfect" today.

"She is monitored by doctors, which is just protocol for anyone that has undergone a stem cell transplant. It's just

routine for her now," she said. "She was a little warrior from the get-go and is now living a normal 7-year-old life."

Last month, Demi and her mother traveled to London for DKMS' London Gala, which was held at The Natural History Museum and even featured famous actor Idris Elba. Demi and Brookes-Wardle were called on stage at the event, where they met for the first


"While Demi and I were on stage at the gala, the crowd looked like a blur in anticipation and excitement waiting for Rob to come on stage with us," Thibodeaux said. "To finally be face to face with the man that selflessly donated his stem cells to Demi, I was in tears. I was thinking this is the hero that gave my little girl a second chance at life!

"Then I couldn't stop hugging him enough."

Brookes-Wardle said that embracing Demi and knowing that his blood stem cells had helped save her life was an incredibly profound and emotional experience.

"The gratitude and joy in her eyes made all the sacrifices and procedures worthwhile," he said.

Thibodeaux said that after meeting

Brookes-Wardle in person, and seeing him bond with Demi, it felt like he had been a part of their family his whole life.

"After meeting Rob in person, we

talked about how crazy and amazing it is that DKMS gave us this opportunity to meet," she said. "We both felt like it was a dream come true."

DKMS is an international nonprofit organization dedicated to the fight against blood cancers and other blood-related illnesses by inspiring people around the world to register as blood stem cell donors. The donor journey begins with a simple swab of the cheek which can be the action that leads to a second chance at life for a patient in need.


Additionally, DKMS works closely with patients and their families, from diagnosis to transplant and beyond. Originally founded in Germany in 1991 by Dr. Peter Harf, DKMS has entities in South Africa, Poland, Chile, the United Kingdom, the United States, and India.

The U.S. office was started in 2004.

me in much the same way music does," she said. "It's comforting to know there's



someone out there who's been through what you're experiencing and had the courage to capture it in writing. The ability to craft words in such a way that they evoke deep emotions and make you feel understood is truly remarkable."

Bruce, who is the mother of two boys, has lived in Luling since 2013 and said she enjoys the laid-back atmosphere of the South. She hopes to help others who have experienced childhood trauma and mental illness stand firm in who they are and who they will grow to be.

Writing isn't Bruce's full-time profession, though she one day hopes that's the case. She currently works in payroll tax data analytics, but her fascination with poetry began in her freshman year of high school thanks to her English teacher, Mrs. Foster.

"She would start each class by playing a song and asking us to write about our feelings toward it," Bruce said. "This practice led me to start journaling my feelings, which eventually evolved into writing poetry to express myself."

Bruce called the last three years of her life "incredibly challenging" after she lost someone deeply important to her. This loss ignited her passion to pursue publishing her poetry.

"A venture he would have encouraged, as he supported all I wrote and chose to share," she said. "Completing the content for the book took around six months."

Working a day job did make it challenging for Bruce to concentrate on her pursuit, though she found ways to get it done.

"I frequently find myself pausing to jot down notes on my phone whenever inspiration strikes, or I ensure I have a journal handy for those moments I can dedicate to writing," she said. "While I don't commit to writing poetry every day, I do make it a point to journal daily as a form of therapy."

Bruce's poetry covers a wide range of themes that include childhood trauma,

breaking cycles, navigating mental health challenges, love, loss and the nuances of friendship. She said the last poem in her collection, called "What I Know to Be True," holds a special place in her heart.

"Reflecting on it now, I can trace the beginnings of my healing journey and my aspirations for the future," she said.

Bruce added that her friends and family have shown tremendous support for her first poetry collection.

"Some of the feedback I received mentioned that it was somewhat difficult to read, given their insider perspective, but there was also a strong sense of pride in my courage to share my journey and emotions," she said.

Wilson said his first menu will be limited to two styles of burgers. The first will be his traditional smash burger made of black Angus brisket patties he is going to ground in house. The burger will include sharp cheddar, house bread, bread and butter pickles and Tallow sauce.

The second burger will have the same black Angus brisket patties but will include foie gras

aioli, red onion jam, Port Salut cheese and house-smoked bacon.

"Really it didn't take too long to come up with this idea. I love making burgers and I love eating them," he said. "I figured it would be a way to bring something to Luling that we really don't have."

Wilson grew up

around the stove watching his grandmother cook at her house, so he took an interest in cooking at an early age. After high school, he worked at several New Orleans restaurants before going to culinary school.

"I've mainly worked in French and Italian restaurants, but I love making all different kinds of fresh pasta," he said. "I love burgers as well, but pasta has always been the one thing that just never feels like work."

Wilson said Tallow's consistency will set them apart from other dining options in the parish.

"A lot of these restaurants that open

here in the parish, not knocking anyone, most places just aren't very consistent. There's very few people in this parish with a true culinary background," he said. "A restaurant here is a gamble to survive, so I figure why not start out small and give it a shot."

Complacency might not be as large a concern as in the past, given the destruction Hurricane Ida caused in 2021. Still, the instinct for many historically has been to ride out a large storm, and that could create major problems were the wrong conditions to arise.

"Evacuations are called because life-threatening conditions are expected," Tastet said. "When residents stay, it is challenging for parish officials and first responders to get the community back to normal after a disaster."

He noted residents can receive the latest information from the parish's Emergency Operations Center via text by signing up for SCP Alerts. One can do so by texting SCPALERTS to 888-777.

"St. Charles Parish has the only 24/7/365 EOC in the state, and we stay prepared for any emergencies that could arise," Tastet said.

According to the NOAA National Weather Service, forecasters project an 85 percent chance of an above-normal season, a 10 percent chance of a near-normal season and a 5 percent chance of a below-normal season.

With that comes a forecasted range of 17 to 25 total named storms with winds of 39 mph or higher. Of those, eight to 13 are forecast to become hurricanes (winds of 74 mph or higher) including four to seven major hurricanes (category 3, 4 or 5; with winds of 111 mph or

Forecasters have a 70 percent confidence in these ranges, according to NOAA, which also notes this hurricane season is expected to have above-normal activity due to a confluence of factors, including near-record warm ocean temperatures in the Atlantic Ocean, development of La Nina conditions in the Pacific, reduced Atlantic trade winds and less wind shear, all of which tend to favor tropical storm formation.

# DHS alum Jefferson earns largest WR contract in history

Has highest per game receiving average of all-time

Since he entered the NFL in 2020, Justin Jefferson has maintained a level of play that could see him finish his career one day recognized as one of the very best to ever do it at wide receiver.

The St. Rose native and Destrehan High School alum's hard work has been rewarded – and then some.

The Minnesota Vikings and Jefferson recently came to a contract agreement that makes the four-year pro the richest wide receiver in NFL history. His four-year, \$140 million contract extension comes with \$110 million in guaranteed money and an average salary of \$35 million a year. It also stands as the richest contract ever for a non-quarterback.

The former Wildcat and LSU Tiger's production made it not a matter of if, but when such a deal would be announced – his numbers, through four seasons, by several measures ranks as the best start to a career at his position in league history. Jefferson is one of five

players ever with 5,000-plus receiving yards in his first four seasons, and his 5,899 career yards are nearly 400 more than any other player in NFL history over a respective four-year start. His career mark of 98.3 receiving yards per game is the best of any receiver in league history that's played at least 50 games.

Last season, Jefferson hauled in 68 receptions for 1,074 yards and five touchdowns. In terms of total numbers, it was the least prolific of his career thus far, but that comes with a major asterisk: he missed seven games due to injury, and he averaged more than 100 yards per game in his 10 starts; in fact, his average of 107.4 yards per game was the best mark of his career.

He began the season with three games of 149 yards or more, then followed up with an 85-yard, two touchdown effort against the Carolina Panthers. He was injured the next week against Kansas City and it cost him more than two months.

Jefferson returned in December, and it did not take him long to shake off the rust, if any. In a pair of games against the eventual NFC finalist Detroit Lions, Jefferson tallied six catches for 141 yards and a touchdown, then in the final game of the season he tallied 12 catches for 192 yards and a touchdown – his best statistical game of the year. Jefferson played his final five games, including those two performances, without starting quarterback Kirk Cousins, who was injured midway through the season.

Jefferson entered the 2022-23 season, his third as a pro as the player with the most receiving yards through his first two seasons in NFL history. All he did was follow up on that with his very best season, which earned him honors as the NFL's Offensive Player of the Year. His 128 receptions for 1,809 yards set new franchise record

marks for Minnesota Vikings team that has seen to COVID-19, he adjusted to the highest level of all-time greats like Randy Moss and Cris Carter competition instantly. His 1,400 yards was an come through the ranks. He scored nine touchdowns this season, with eight coming through the air and one on a run.

Jefferson received 35 first-place votes and 192 points that season, finishing ahead of the runner-up Mahomes' 10 first-place votes and 75

In addition to the OPOY honor, Jefferson's 4th and 18 reception that was key in Minnesota's 33-30 upset over the Buffalo Bills was voted the NFL's Best Moment of the Year for 2022-23.

Jefferson blossomed as an upperclassman at Destrehan and went on to sign with LSU, where he quickly found a rapport with quarterback and future No. 1 overall pick - Joe Burrow. He helped guide LSU to a national championship as a junior, when he recorded 111 receptions for 1,540 yards and 18 touchdowns. As a sophomore, he caught 54 passes for 875 yards and six touchdowns.


He was chosen in the first round, 22nd overall by Minnesota in 2020. Despite the elimination of most preseason activities across the NFL due

As an NFL sophomore, he expanded his game and his statistics, catching 108 passes for 1,616 yards and 10 touchdowns.

Off the field, Jefferson has proven one of the league's most marketable talents. His trademark Griddy touchdown dance is popular and often imitated, and he is a top ambassador for Under Armour.

He's also never forgotten his hometown and region, returning regularly for appearances and making charitable contributions to his






