IT IS HEREBY ORDERED AND DECREED that:

- 1.A Temporary Restraining Order shall issue immediately and that security in the amount of \$5,000.00 be posted no later than the 12th day of September 2023;
- 2. Defendant, Louisiana Leadership Fund, LLC, shall be enjoined from running, distributing, or transmitting any advertisement stating any of the following:
- a. A lawsuit filed against Jeff Landry's office stated that a wealthy donor found with child pornography had a personal connection with Landry.
- b. A wealthy donor found with child pornography had a personal connection with Jeff Landry;
- c. A perpetrator who possessed child pornography had a personal connection with Jeff Landry;
 - d. A donor to Jeff Landry possessed child pornography;
 - e. Jeff Landry waited a year before charging a donor alleged to possess child pomography;
- f. Jeff Landry waited a year before charging a perpetrator alleged to possess child pornography;
- 3. Defendant, Louisiana Leadership Fund, LLC, shall instruct any broadcaster running any advertisement in violation of Section 2 above to immediately remove from the airwaves any such advertisement;

4. This Order shall remain in full force and effect until such time as this Court specifically orders otherwise and will expire on its own terms on September 21, 2023;
