HB 191 is a wolf in sheep's clothing. It purports to advance the cause of justice, but in fact does the opposite.

The First Amendment prohibits Congress, or indeed any law-making entity, from prohibiting the "free exercise" of religion. This patently is not restricted to houses of worship, otherwise First Amendment protections would vanish as soon as one stepped outside. No, the "free exercise" of religion means the freedom to live according to one's sincere and deeply held religious beliefs in every sphere of life, whether in an individual capacity or in cooperation with other like-minded citizens.

Yet HB 191 would trample on this constitutional protection. Section 8 of this bill attempts to strip religious organizations and non-profits of their freedom to apply moral criteria – informed by their sincere and deeply held religious beliefs – to occupants of their residential facilities.

This would have the effect of making void any religious test for housing by a religious organization or non-profit in their own residential facilities – which, on its face, is a blatant violation of the First Amendment. If their religion teaches that there are only two sexes, that these sexes are fixed at conception, and that sexual desire is naturally ordered toward members of the opposite sex; and if HB 191 criminalizes excluding people from housing who reject or flaunt these principles; then, ipso facto, a religious organization or non-profit cannot prefer members of its own religion in its housing decisions. This is inimical to the letter and spirit of the First Amendment.

There is another problem with this bill that is even more insidious because it endangers the physical safety of women, including some of the most vulnerable members of our society.

Section 10 would force schools, rescue missions, rehabilitation programs, domestic violence shelters – in short, any program which provides housing, even those that are privately run and operate according to religious principles – to place a gender-confused person in the residential facility corresponding to the gender of their choice.

Practically speaking, this would mean that men who believe they are women – and even men who don't believe they are women, but are "perceived" (according to the bill's text) not to conform with "commonly associated" markers of the male sex – must be allowed to sleep alongside women, enter women's restrooms, and use women's showers and locker rooms.

This puts every female resident at risk of being raped, assaulted, or harassed by men in the very spaces where they should expect the most safety and protection. Again, it should be emphasized that the bill does not require that a person's so-called "gender identity or expression" be sincere or even verified by a licensed physician or mental health practitioner. A man can simply say he's a woman, or pretend to act like one, and HB 191 would require that he be housed with women.

This is madness. Vote NO on HB 191.

Hello Chair, and members of the committee, my name is Robert Salcido, Jr., I'm from San Antonio and I'm here to testify in support of HB 191. I have the privilege of serving as the executive director at Pride Center San Antonio, our local LGBTQ+ community resource center. While our resource center is located in the heart of San Antonio, we serve the greater Bexar County and surrounding areas. Among the thousands of calls and walk-ins we receive each year, the highest percentage are from LGBTQ+ identified people seeking resources where they can be their authentic selves, be treated with dignity, respect, and compassion, without fear of discrimination and harassment.

Right now, LGBTQ+ Americans are facing undue discrimination in employment, public accommodations, housing, and in other sectors of their public life, they have virtually no legal recourse in much of the country, including in Texas. Housing continues to be an area where LGBTQ+ people face discrimination through being refused the ability to rent & buy housing, unfairly evicted, charged higher rental rates, & harassment by landlords & neighbors. Nondiscrimination protections simply ensure that everyone has a fair shot to succeed based on their own hard work, without undue barriers simply because of who they are.

Last year, our Center along with researchers from Dell Medical School and Trinity University released the San Antonio Strengthening Colors of Pride Community Report that included data collected from over 1800 LGBTQ+

community members in the San Antonio metro area. Our findings were that 11.1% of LGBTQ+ people reported being denied housing due to their gender identity & 12.4% because of their sexual orientation. Furthermore, of our respondents, 44.6% of transgender men & 31.8% of transgender women
