## 1. Introduction - Recap

The Global Initiative to End Wildlife Crime (EWC) was first announced on 3 March 2019 (UN World Wildlife Day) at the House of Lords in London and officially launched on 5 June 2020 (UN World Environment Day).

#### Governance

EWC is governed by a Steering Group, has an independent chair, is hosted by the ADM Capital Foundation, and works with the support of Special and Technical Advisors and International Champions.

Since its launch EWC has structured its work into the following streams:

- Technical and Legal Analysis
- Communications and Outreach
- Strategic Partnerships
- State support

#### 2. Workstream Progress

### **2.1 A Fourth Protocol under the United Nations Convention Against Transnational** Organised Crime (UNTOC)

#### **Presidential Statements**

- Costa Rica and Gabon called for a Fourth Protocol: in May 2021, the Presidents of Costa Rica and Gabon made an <u>historic joint announcement</u>, calling for a new global agreement on wildlife crime, taking the form of a Fourth Protocol under UNTOC against the illicit trafficking in wild fauna and flora. Their call was conveyed to the opening general plenary of the Thirtieth Session of the UN Commission on Crime Prevention and Criminal Justice (CCPCJ) on the same day by Gabon's Minister for Environment, Forest and Oceans, Prof. Lee White CBE. An opinion piece by the two presidents was also published in the <u>China Daily</u>. The Global Initiative to End Wildlife Crime (EWC) welcomed the announcement in a press release that can be found <u>here</u>.
- Angola joined call for Fourth Protocol on wildlife crime: on 21 September 2021, the President of Angola, H.E. João Lourenço, announced that Angola will join with Gabon and Costa Rica in promoting a Fourth Protocol on wildlife crime under the UNTOC, noting that a new global agreement is needed to tackle these highly destructive crimes. The announcement was made at the International Conservation Caucus Foundation U.S. Congressional International Conservation Leadership Awards Dinner, which was held in Washington D.C. EWC formally congratulated President João Lourenço in a press release that can be found here.

#### **Other Expressions of Support**

- UN Crime Congress: in March 2021, at the 14th United Nations Congress on Crime Prevention and Criminal Justice, Lord Hague speaking on behalf of the Duke of Cambridge referred to EWC and included a Fourth Protocol under UNTOC as one of four "specific actions I believe we should take".
- **EU Organised Crime Strategy**: in April 2021, the European Commission publicly expressed its support for a Fourth Protocol in the <u>EU Strategy to tackle Organised Crime 2021-2025</u>, stating: "Finally, since the international dimension of wildlife trafficking is crucial, the Commission will promote the adoption of an additional Protocol under the UNTOC."
- **Dr. Jane Goodall:** on 5 June Dr Goodall released a <u>statement</u> personally congratulating EWC on its first anniversary, and expressed, once again, her support for a Fourth Protocol. The Jane Goodall Institute Global has been an International Champion of EWC since September 2020.

• Steering Group and International Champions: EWC International Champion's network stands at <u>25</u>. The Steering Group now comprises representatives of ADM Capital Foundation, African Wildlife Foundation, Born Free Foundation, Global Environmental Institute, the International Conservation Caucus Foundation (ICCF), the Food and Land Use Coalition (represented by SYSTEMIQ), Freeland and is chaired by John Scanlon AO.

#### Progress Within the UN System

- **UN Crime Congress:** EWC hosted an <u>Ancillary Meeting</u> at the 14th United Nations Congress on Crime Prevention and Criminal Justice, titled "The Rationale for, and Possible Form and Content of, a New Global Agreement on the Illicit Trafficking of Wildlife". The event featured experts in the fields of public policy, criminology, and environmental protection to explain the rationale for a Fourth Protocol on illicit wildlife trafficking, and to outline the process by which it can be realised.
- UN CCPCJ Thematic Discussions: in November 2021, Angola made an intervention during the Thematic Discussions of the CCPCJ on the Implementation of the Kyoto Declaration, calling for the adoption of a new global agreement on wildlife crime, taking the form of a Fourth Protocol. At the same event, EWC also delivered a <u>statement</u> showing how biodiversity loss, climate change and the risk of future wildlife-related pandemics are exacerbated by the illicit trafficking of wild animals and plants, stressing the importance of embedding the illicit trafficking of wildlife into the international framework through an additional UNTOC protocol.
- Engagement with Vienna-based Permanent Missions: in November 2021, members of the EWC team held productive meetings with ambassadors and other high-level representatives from 13 Permanent Missions in Vienna. These meetings included discussions on a possible draft CCPCJ resolution to consider the potential benefits of adopting an additional Protocol under the UNTOC (which is similar to the approach adopted by the World Health Assembly in considering a Pandemics agreement or treaty), and the level of interest in co-sponsoring such a resolution.

#### 2.2 Adopting a "One Health" approach to wildlife trade

- **CITES Standing Committee Working Group:** EWC and its Champions actively participated in the work of the Working Group "on the role of CITES in reducing risk of future zoonotic disease emergence associated with international wildlife trade".
- Engagement with World Health Organisation (WHO): EWC wrote several letters to the WHO Director-General, Dr Tedros Adhanom Ghebreyesus, and had multiple productive conversations with senior staff members of the organisation.
- **EWC response to proposed international Pandemics agreement or treaty:** EWC <u>welcomed</u> the decision of the World Health Assembly in May 2021 to explore the benefits of an International Pandemics agreement or treaty and urged the WHO and interested States to ensure that any such Treaty helps to prevent future pandemics that could emerge from human interaction with wild animals, and to institutionalise a 'One Health' approach to wildlife trade and markets.
- **Special Session of the World Health Assembly:** in December 2021, EWC <u>welcomed</u> the decision of the World Health Assembly to begin drafting and negotiating a convention, agreement or other international instrument under the Constitution of the WHO to strengthen pandemic prevention, preparedness and response.
- International Alliance against Health Risks in Wildlife Trade: EWC joined the German Government-funded International Alliance against Health Risks in Wildlife, an inclusive and interdisciplinary platform, which focuses on human-wildlife interfaces, the associated health risks and the emergence and spread of zoonotic pathogens from wildlife.

#### **2.3 Species Risk Assessment**

• Species360, Species Risk Assessment: as an international Champion of EWC, Species360, is leading a study in collaboration with the University of Liverpool, the City University of Hong Kong, and the University of Southern Denmark to assess the potential risks of legal and illegal wildlife trade on the spillover of diseases listed by the WHO Research and Development Blueprint Strategy ('BP diseases').

#### 2.4 Convention on Biological Diversity (CBD) Post 2020 Global Biodiversity Framework

- **Response to the Updated Zero Draft:** EWC reviewed the Updated Zero Draft of the Post-2020 Global Biodiversity Framework and submitted a <u>response</u> calling for stronger provisions on both the illicit trafficking of wildlife and the need to take a holistic, precautionary approach to wildlife trade.
- **Response to the First Draft:** EWC reviewed the First Draft of the Post-2020 Global Biodiversity Framework and submitted a <u>response</u> that reiterated some of its previously expressed concerns. As an alternative to the addition of a new separate target on the illicit trafficking of wildlife, EWC later recommended <u>editing</u> the language of a the existing Target 5.

#### 3. Communications and Outreach

#### Increasing Awareness and Take up of our Key Messages

In order to build awareness and ultimately support of EWC's two proposals we have engaged extensively with a broad range of stakeholders. Outreach has been the participation in and organisation of webinars, the use of social media and production of videos. In response to these efforts we are increasingly seeing EWC's proposals referenced and supported in research and high-profile events and a heightened level of country interest. A summary of these activities is provided below.

#### **3.1 Events and Publications**

- LinkedIn: Since its launch in August 2020, EWC's LinkedIn has reached 2,287 followers, a 45% increase since April 2021 progress report. Between January and December 2021, the account achieved over 58,600 impressions and generated 38,093 unique visitors.
- Website: over the same period, EWC's <u>website</u> generated over 6.1k unique visitors across 8.1k sessions with an average session duration of 1m 17s. Peaks in traffic have coincided with press releases and webinars.

#### Media Releases and Coverage

In 2021, EWC has shared seven press releases covering its work and updates. The releases were also distributed through EWC's own networks and shared through the Champions network. Through tracking media clippings, and web searches, the initiative has been covered in over 60 clippings, this includes news articles, webinars, events, LinkedIn articles and Op-eds. #### UNTOC

**The Commission on Crime Prevention and Criminal Justice (CCPCJ)** acts as the principal policy making body of the United Nations in the field of crime prevention and criminal justice and is the preparatory body to the United Nations Crime Congresses.
