#### **About This Report**

This report provides information on the General Fund impacts of pending legislation at the 2025 legislative session using data from Legislative Council Staff Fiscal Notes. Data is provided by fiscal year on separate tabs in this worksheet. The Summary Tab provides the net General Fund budget impact for all years. Note: actual appropriations may differ from the estimated expenditure amounts.

#### **General Fund Impacts**

This report shows the net impact of bills on the General Fund (GF) after accounting for changes in GF Revenue, GF Expenditures, and Transfers to and from the GF. The net impact is calculated as follows:

#### Net GF Impact = Revenue - Expenditures + Transfers

So for example a bill that decreased revenue by (\$5,000) and increased spending by \$10,000 would have net impact of (\$15,000), i.e., the amount of General Fund available to spend or save is decreased by \$15,000. Cash Fund impacts do not show up in this report.

#### **TABOR Refunds**

Because TABOR refunds may be affected by the broader revenue situation, the Summary Tab shows the Net General Fund Impact of all pending bills both with and without the impact of changes to TABOR Refunds. For individual bills shown on the fiscal year and Appropriations Committee tabs, Net General Fund Budget Impact exlcudes TABOR refunds
